It has been an unsettling year for many squash players with training, tournaments, social events and Super Champs, NZ Champs and more all falling victim to Covid-19.

Financially Squash Central, like so many regions and other sports in New Zealand, took a major hit. Many training camps, Championships and teams events were cancelled, some after money had been paid for accommodation, flights and so forth.

However, through it all there were still many achievements and successes as you will see in the following reports, which goes to show just how resilient squash players are and what a great sport it is.

Squash NZ have had several changes over the past year. CEO Martin Dowson has restructured Squash NZ Head Office and has been very prominent in his quest to be more available to the clubs and regions – many texts, phone calls and a very clear hand on the pump attitude has been welcomed and appreciated. One clear change of direction is the back to basics, look after the joe average player directive being promoted through to us.

The nationwide survey asking players and clubs for their thoughts on numerous points was answered by over 2000 players and the Council of Clubs Hui hosted by Whanganui was well received by all of our Central clubs. As we continue to review own strategic direction, I feel Squash NZ are doing a far better job at aligning with the districts.

With the words of our past President, Christine Rukuwai solidly at the forefront of our key direction points and the adaptation of our own strategic plan, there is a pathway for the next committee to focus on the 4 key areas of importance to Central Squash over the next 5 years. These are:

1. Encouraging and growing participation
2. Development of members, coaches, players and referees
3. Capability
4. Communication and Marketing

Fruition of some great ideas and determined minds through the committee are starting to reap benefits as we help negotiate our district through the murky waters of the unknown.

A big thank you to all the staff, coaches, managers, and volunteers who have all been involved in Squash Central. There were some great ideas and support from these people during the year to keep everyone motivated and active.

Also, a massive thanks to all the clubs, their committees and players for accepting and tolerating the untimely return to lockdown just as NZ was showing signs of moving back into some sort of normality. Thank you for being safe, responsible and mature about the way you handled Covid and its out reaching problems.

One of our key wins this year was the Employment of Kaye Carter as District Coaching Facilitator. An initiative now being adapted by Squash NZ in principle.

The Calendar is looking very full and exciting for Central Squash 2022 including hosting some national events such as Whanganui hosting a PSA challenger tournament and Kawarua Park being awarded D grade national Superchamps.

I would like to thank the Committee for their efforts this year, they all quickly adapted to many emails and zoom meetings. We even managed to take the board meeting on tour to Taihape. (I'm pretty sure our juniors are still asking who all these people who rocked up to their Central Champs are!!!).

Our committee has grown into a very tight unit. Our Team was very thoughtful and considerate on some very tough topics of discussion and decisions being made throughout the year. We are lucky to have such a unified and skilled committee and I appreciate the depth of the committee's knowledge which has proved valuable on many occasions. As we grew as a team more and more frank discussions were had, I am so thankful that all our committee took on the 'Open Door' policy.

A special thanks to Pauline Slovak for her hours and hours of work behind the scenes in keeping the squash wheels turning. Pauline is our Super Administrator and works tirelessly for our sport. To John Laurenson who puts together the tricky puzzle that is the calendar each year. I have witnessed the frustrations John goes through and no wonder he pulls his hair out with some of the changes that are asked for.

Our Treasurer Pauline Waite has had the arduous task of balancing our books, as you know our budget was not accepted by our members last year and it was left to Pauline and a small group to make a budget work. Some hard choices had to be made and we made it work!

Anneka was the Communications Representative and has done a fabulous job connecting members to what is happening in the district through our media platforms and along with Pauline was instrumental in getting Central Districts involved in World Squash Day.

To Brett Cook, Mike Jack, Daryl O'Hara, and Shaun Dyer, I owe a debt of gratitude, You guys are the stabilisers, not shy in doing the hard yards and forthcoming with advice and support to all committee when needed.

Our district is lucky to have a committee of this calibre. Please accept our huge appreciation for the input you have had. TREASURER'S REPORT

We were fortunate to secure over \$26,000 in grants this year from NZCT, E&C Trust, Southern Trust, Pelorus Trust, TAB Gaming Trust and Lion Foundation, sadly some of these monies had to be returned as they were specifically for the Junior and Senior Nationals which were cancelled.

Expenditure this year was slightly less than Income resulting in a small surplus due mainly to the cancellation of all National events. We have a balance of \$62,613 in our Cheque account and \$11,262 on Investment in the TSB Bank.

The budget for 2022 has been based on 2021 figures including an amount for grants we intend to apply for mainly to assist teams to their National events.

INDEPENDENT ASSURANCE PRACTITIONER'S REVIEW REPORT

TO THE MEMBERS OF CENTRAL SQUASH ASSOCIATION (INCORPORATED)

Report on the Special Purpose Financial Statements

We have reviewed the special purpose financial statements on pages 1 to 8 of Central Squash Association (Incorporated), which comprise the statement of financial position as at 30 September 2021, and the statement of financial performance and statement of movement in general funds for the year then ended, and notes to the financial statements.

Committee's Responsibility for the Special Purpose Financial Statements

The Committee is responsible for the preparation of these special purpose financial statements in accordance with the accounting policies of the society and for such internal control as the Committee determines is necessary to enable the preparation of the financial statements that are free from material misstatement, whether due to fraud or error.

Assurance Practitioner's Responsibility

Our responsibility is to express a conclusion on the accompanying special purpose financial statements. We conducted our review in accordance with International Standard on Review Engagements (New Zealand) (ISRE (NZ)) 2400, Review of Historical Financial Statements Performed by an Assurance Practitioner who is not the Auditor of the Entity. ISRE (NZ) 2400 requires us to conclude whether anything has come to our attention that causes us to believe that the special purpose financial statements, taken as a whole, are not prepared in all material respects in accordance with the accounting policies of the society. This standard also requires us to comply with relevant ethical requirements.

A review of special purpose financial statements in accordance with ISRE (NZ) 2400 is a limited assurance engagement. The assurance practitioner performs procedures, primarily consisting of making enquiries of management and others within the entity, as appropriate, and applying analytical procedures, and evaluates the evidence obtained. The procedures performed in a review are substantially less than those performed in an audit conducted in accordance with International Standards on Auditing (New Zealand). Accordingly, we do not express an audit opinion on these special purpose financial statements. Other than in our capacity as assurance practitioner we have no relationship with, or interests in, Central Squash Association (Incorporated).

Basis for Qualified Conclusion

Control over income other than affiliation fees, grants and interest, prior to being recorded is limited and there are no practical assurance procedures to determine the effect of these limited control. Consequently, we were unable to determine whether any adjustments to these amounts or their related balances were necessary.

Qualified Conclusion

Based on our review, except for the effects of the matter described in the Basis for Qualified Conclusion paragraph, nothing has come to our attention that causes us to believe that the special purpose financial statements of Central Squash Association (Incorporated) as at 30 September 2021, and its financial performance for the year then ended, are not prepared, in all material respects, in accordance with the accounting policies of the society.

Emphasis of Matter

Without modifying our conclusion, we draw attention to statement of accounting policies, which describes the basis of accounting. These are special purpose financial statements and have been prepared in accordance with the policies determined by the Committee for the benefit of the members. As a result, the financial statements may not be suitable for another purpose. Our conclusion not qualified in respect of this matter.

Restriction on Responsibility

This report is made solely to the Members, as a body. Our review work has been undertaken so that we might state to the committee those matters we are required to state to them in a reviewer's report and for no other purpose. To the fullest extent permitted by law, we do not accept or assume responsibility to anyone other than the members as a body, for our review work, for this report, or for the conclusion we have formed.

1. STATEMENT OF ACCOUNTING POLICIES

Central Squash Association (Incorporated) is an incorporated society, registered under the Incorporated Societies Act 1908

These special purpose financial statements have been prepared in accordance with policies determined by the Board for the benefit of the members.

These financial statements do not include the activities or balances of the Central Squash Trust

MEASUREMENT BASE

The accounting principles recognised as appropriate for the measurement and reporting of earnings and financial position on a historical basis are followed by the entity.

SPECIFIC ACCOUNTING POLICIES

REVENUE

Affiliation and competition income is recorded once an invoice has been raised. Grants, donations and interest are recorded when they are received unless there is a condition attached in which case it is recognised as a liability until it is spent

ACCOUNTS RECEIVABLE

Accounts receivable are stated at their net realisable value.

CLOTHING ON HAND

Inventories are valued at the lower of cost and net realisable value, on a first in-first out basis.

FIXED ASSETS

All fixed assets are recorded at cost less accumulated depreciation to date. Depreciation has been provided at the maximum rates permitted by the Income Tax Act 1994

INCOME TAX

The society is exempt from income tax as an amateur sports body under Section CW 46 of the Income Tax Act 2007

CONDITIONAL GRANTS

GOODS AND SERVICES TAX
